USBC Sanctioned Rules and Regulations

Only members of the **Greater Holland USBC** are eligible to bowl in this tournament. Entries may be left at BAM, Northland or Lakeview Lanes.



Handicap is 90% based from 230 scratch. Prize ratio: at least 1 for 10 entries. Prize fund returned 100%. Prize money will be paid 90% handicap, 10% actual. All rules and regulations concerning conduct of this tournament not specified herein shall be governed by the rules of USBC.

NOTE AVERAGE REQUIREMENTS: Entrants shall use the Greater Holland Bowling Assoc. tournament average, based on 18 games or more over a 3-year period. If no tournament average, then entrants will use their highest 2023-2024 average established in a USBC certified league. If no previous season's average, entrant shall use their highest current average of 21 games or more, verified with an individual record sheet. If none of the above applies, entrant shall bowl scratch at 230. **NO TEN PIN RULE**

Failure to use the proper average or make a correction prior to completion of the first game of the series shall disqualify the score if submitted average is lower than actual average. If submitted average is higher than actual, prize winnings will be based on this average.

Bowlers must be aware of rerating requirements of USBC-Rule 319c of the USBC Rule Book. All average adjustment rules in Rule 319 shall apply.

Tardy players will start in frame being bowled, with zero being given for every frame missed.
